1901.31(G) ON THE FIRST MONDAY IN JANUARY OF EACH YEAR, THE CLERK SHALL MAKE A LIST OF THE TITLES OF ALL CASES IN THE COURT THAT WERE FINALLY DETERMINED MORE THAN ONE YEAR PAST IN WHICH THERE REMAINS UNCLAIMED IN THE POSSESSION OF THE CLERK ANY FUNDS, OR ANY PART OF A DEPOSIT FOR SECURITY OF COSTS NOT CONSUMED BY THE COSTS IN THE CASE. THE CLERK SHALL GIVE NOTICE OF THE MONEYS TO THE PARTIES WHO ARE ENTITLED TO THE MONEYS OR TO THEIR ATTORNEYS OF RECORD. ALL THE MONEYS REMAINING UNCLAIMED ON THE FIRST DAY OF APRIL OF EACH YEAR SHALL BE PAID BY THE CLERK TO THE CITY TREASURER, EXCEPT THAT IN A COUNTY-OPERATED MUNICIPAL COURT, THE MONEYS SHALL BE PAID TO THE TREASURER OF THE COUNTY IN WHICH THE COURT IS LOCATED. ANY PART OF THE MONEYS SHALL BE PAID BY THE TREASURER AT ANY TIME TO THE PERSON WHO HAS THE RIGHT TO THE MONEYS, UPON PROPER CERTIFICATION OF THE CLERK.

THE FOLLOWING IS A LIST OF TITLES OF CASES IN THIS COURT THAT WERE FINALLY DETERMINED MORE THAN ONE YEAR PAST IN WHICH THERE REMAINS UNCLAIMED IN THE POSSESSION OF THE CLERK ANY FUNDS, OR ANY PART OF A DEPOSIT FOR SECURITY OF COSTS NOT CONSUMED BY THE COSTS IN THE CASE.
