KINSHIP PERMANENCY INCENTIVE

- The Kinship Permanency Incentive (KPI) program is a state initiative that provides kinship families who meet all eligibility requirements and who also have legal custody or guardianship of a kinship youth with time-limited incentive payments.
- Must have court ordered legal custody or guardianship.
- Must live in Portage County.
- Must complete a Portage County Job & Family Services home assessment and placement of child must be approved.
- Must complete background check.
- Families gross income cannot exceed 300% of the Federal Poverty Level.

KINSHIP PREVENTION, RETENTION, AND CONTINGENCY (PRC) OPPORTUNITIES

- Kinship Childcare Program: Childcare assistance for Kinship families of Portage County who need relief of childcare functions so that they can provide and maintain a home for a child in place of a child's parents.
- Kinship Stabilization
 (Supportive) Services:
 Assistance for kinship
 families of Portage County
 who need services that are
 essential to secure or
 maintain employment,
 ensure the health and safety
 of children, prevent the
 removal of children from the
 household, are needed to
 maintain a permanent
 placement or will assist in
 the reunification of children
 with their family or relatives.
- Kinship Support Program: Time-limited support payments for Kinship families of Portage County, even if residing in another county, of \$350 per month per kinship child for 4 months out of rolling 12 months.

KINSHIP SUPPORT PROGRAM

- The Kinship Support Program (KSP) is a state program that provides short-term financial payments to eligible kinship caregivers who are not certified as foster caregivers for the placement of kinship youth in their homes.
- Kinship caregivers do not need to apply for this program. Eligible kinship caregivers will be identified and paid based on the information entered into the Statewide Automated Child Welfare Information System (SACWIS). There is no application for this program. Payments will be sent directly to kinship caregivers on the 10th of every month
