Sealed proposals will be received at the office of the Portage County Director of Internal Services, Portage County Administration Building, 449 South Meridian Street, Ravenna, Ohio, until 2:00 PM on Wednesday, August 2, 2023, at which time and place the proposals will be opened and read to the public in the lobby of the building entrance off Chestnut Street.

Proposals will be received for the following items of work:

MANTUA WWTP CLARIFIER COVERS

The Contractor shall provide all labor, material, and equipment necessary to stage, assemble, install, and ensure the proper performance of the launder cover system within the two clarifier tanks. The project is located at the Mantua Wastewater Treatment plant at 4500 Orchard Street, Mantua, Portage County, Ohio.

Estimated Costs of Construction:

Mantua WWTP Clarifier Covers: \$73,500

The Contractor shall familiarize himself with all of Section 20, including 'Information and Instructions to Bidders' and 'Special Construction Requirements' prior to bidding.

All bids must be submitted on the bid forms included in the Contract Documents and returned with the bid book in its entirety.

The Bid Guarantee is conditioned to provide that if the Bid is accepted and awarded, the Bidder will enter into a contract with the County and will file a Performance Bond as required.

The Bidder to whom the Contract is awarded will be required to furnish a Performance Bond in the sum of 100 percent of the Contract price for the faithful performance of the Contract. If the Bidder selects "Bid Guarantee" Option A, the Bidder may use this Bond as the Performance Bond.

Each Proposal must contain the full name of the party or parties submitting the documentation and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity. The bidder shall purchase the plans and a contract book to become a qualified participant before final bid submittal. All questions shall be directed to the Portage County Water Resources Department in writing to jandrassy@portageco.com. The Owner intends and requires that the project be

completed no later than one hundred and twenty (120) calendar days after the "Notice to Proceed" is issued.

Each Proposal must be sealed and marked "Mantua WWTP Clarifier Covers, Project No. MV-0 (23-130)."

Domestic Steel use requirements as specified in section 153.011 of the revised code apply to this project. Copies of section 153.011 of the revised code can be obtained from any of the offices of the Ohio Department of Administrative Services.

The Portage County Commissioners reserve the right to waive any informality or to reject any and all bids.
