The Contractor shall provide all labor, material and equipment necessary for 5,000+ lineal feet of 8 inch diameter and 2,000+ lineal feet of 6 inch diameter polyvinyl chloride gravity sanitary sewer, 17 access manholes, service laterals, and bored crossings with and without steel casing. Project provides a new centralized sewer system for the existing 57 lot residential subdivision located within Brimfield Township, Portage County, State of Ohio.

10.01 ADVERTISEMENT FOR BIDS

The Bid Guarantee is conditioned to provide that if the Bid is accepted and awarded, the Bidder will enter into a contract with the County and will file a Performance Bond as required.

The Bidder to whom the Contract is awarded will be required to furnish a Performance Bond in the sum of 100 percent of the Contract price for the faithful performance of the Contract. If the Bidder selects "Bid Guarantee" Option A, the Bidder may use this Bond as the Performance Bond.

Each Proposal must contain the full name of the party or parties submitting the documentation and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity. The bidder shall purchase the plans and a contract book to become a qualified participant before final bid submittal. All questions shall be directed to the Portage County Water Resources Department at 330-297-3670. The Owner intends and requires that the project have a completed fully operational system no later than 210 calendar days after the "Notice to Proceed" is issued, and complete restoration within 30 days thereafter.
