Discussion:

1. Budget

Director Harris asked about the increased percentage amount for those departments who did not participate in the Compensation Management study and the Board agreed to provide an average of 3%. Director Harris will bring back a Journal Entry to move forward next week.

Sheriff's Radios: The Sheriff's Office hasn't done a sweeping purchase since 2008 and they need of 150 walkie-talkies and 22 mobile radios. If the radios are purchased now, it would save the County \$1,000 per radio or \$150,000 total. The Board agreed to move forward with the request and Director Harris will bring back a Resolution next week.

OSU Extension: Commissioner Christian-Bennett noted in the past, the Board provided \$90,000 to the Extension Office and they are asking for a modest increase. Commissioner Christian-Bennett will provide the numbers to Director Harris.

Commissioner Christian-Bennett asked about the budget discussions with the Elected Officials and Director Harris replied he has one remaining department to meet with and he's still waiting for Director Townend's information. Director Harris will prepare a report for his December 2nd budget meeting with the Board.

1. Introduction – Lisa Reeves
Ms. Reeves is the CDBG Specialist for the Regional Planning Commission, and she will be
explaining the program to the Board and the general public.

The Regional Planning Commission is preparing the application on behalf of the Board of Commissioners and Family and Community Services.

2. Presentation of the Grant Application - Lisa Reeves

2021 Target of Opportunity CARES Act (CDBG-CV) Program

Family & Community Services, Inc. operates a transitional housing program in Portage County called Portage Area Transitional Housing (PATH). This program serves low-moderate income clientele who are experiencing homelessness and are in need of intensive case management to promote stable housing at program exit. PATH provides a total of six (6) units to families in need and serves the most vulnerable populations in Portage County. There are approximately 18 individuals served by this program each year.

Family & Community Services, Inc. also operates a permanent supportive housing program in Portage County called Interagency Support Services Providers (ISSP). This program serves low-moderate income clientele who are experiencing homelessness and have disabilities that warrant a need for supportive services in order to maintain stable housing. ISSP provides a total of 18 units to individuals and families in need and serves the most vulnerable populations in Portage County. There are approximately 30 individuals served by this program each year. Family & Community Services, Inc. is requesting funding for hard surface flooring and HVAC updates at its Supportive Housing Program funded "transitional housing". The hard surface flooring will provide Family & Community Services, Inc. with the ability to better clean and sanitize facilities and current HVAC units will updated with more efficient models to provide improved air filtration and purification. These improvements will help Family & Community Services, Inc. better prevent the spread of COVID-19, and more effectively respond to the pandemic. These facility improvements will also create long term impact by increasing housing quality and access, therefore enhancing housing stability for those served by this program.

The buildings to be renovated are as follows:

Transitional Housing

- 161/163 Currie Hall, Kent City (2 units)
- 1540/1542 Benjamin Court, Kent City (2 units)
- 1536/1538 Benjamin Court, Kent City (2 units)

Permanent Supportive Housing

- 1019 1033 Graham Road, Kent City (10 units)
- 1548/1550 Benjamin Court, Kent City (2 units)

Two-Hundred Fourteen Thousand One Hundred Dollars (\$214,100) (excludes administration) in CDBG funds will be used to remove all existing flooring, minimal floor prep/subfloor replacement and installation of new vinyl plank flooring in 18 units as well as the replacement of horizontal furnace/air handler in two (2) units. The administration is estimated at \$21,000 and will be added to the \$214,100.

3. Questions:

Mr. Ames noted he had a question and Commissioner Christian-Bennett proceeded to swear him in as follows:

Do you solemnly affirm under the penalties of the law of perjury of the State of Ohio that the testimony you are about to give shall be the truth, the whole truth and nothing but the truth? Please respond: I do.

Mr. Ames noted a public hearing is for the public and this is being presented not as a public hearing, the public members haven't been given whatever we are looking at. It's a sham. He is live streaming this to the public and all they see is the back of a head sitting at a table. That is not a public hearing. It's just another department coming in and that's the way it's being conducted and that is not proper.

Ms. Reeves mentioned if anyone would like to see the grant application, it's available. Mr. Ames requested a copy of the hearing handouts and Ms. Reeves immediately presented him with a copy.

Director Peetz noted the pre-application was submitted to the state and they are looking forward to assisting.

PUBLIC COMMENT

Present: Brian Ames

Mr. Ames had a concern about public records, particularly the reliance of the meeting minutes on the Auditor's records (Then & Nows). The Auditor's Office is on a 5-year retention schedule and the Courts have already said that you need to keep your own records, you can't rely on the Auditor's records. There are 5 years of records at the Auditor's Office that have not been retained by the Commissioners and they are going to fall off the cliff. In order to preserve the accuracy of the Commissioners' records, you need to capture the records from the Auditor's Office, so they are not disposed of. When Mr. Ames inquired whether that was being done, he was told there was no plan to do that, and nobody seemed to be aware they were on a 5-year retention. Mr. Ames wants to ensure that we don't have a situation where we can prevent the records from being incomplete and we can prevent this by taking the action to preserve the records now. There are a lot of records that have already been disposed of and there's no way to get them back, but we can prevent more of that from happening by taking action and attaching the records.

PUBLIC COMMENT

Present: Barb Tittle

Ms. Tittle inquired about the money authorized to pay for the Sheriff's radios and she remembered back in the summertime, the Board specifically talked about a state grant that was available for that purpose and Commissioner Christian-Bennett noted the grant was for body cameras for the Sheriff's Office. Administrator Crombie pointed out that the Board hired a new Grants Administrator that will work closely with the Sheriff's Office.

Discussion:

1. Iraquois Drive, Brady Lake (Kent)

Mr. Heeter is interested in purchasing a home on Iraquois Drive that encroaches on County property and Mr. Heeter would like to know if the Board will sell the property to him for \$1.00? Commissioner Kline asked how large is the parcel and Commissioner Christian-Bennett explained it's a cookie-cutter lot in Brady Lake and the Board previously attempted to resolve this situation but received no response. The bulk of the house Mr. Heeter is trying to purchase is on the County's property. The Prosecutor's Office indicated the Board needs to consider 2 items: (1) whether the land is no longer needed for any public purpose and if not (2) establish the fair market value because real property sold to a private party will need to be sold for its fair market value if the Board determines it has no public use of the property.

Commissioner Christian-Bennett read the history and explained the home at 2259 Iraquois Drive is almost entirely built on the lot owned by Linda Kitchen Mullen and the Mullen home is almost entirely built on the County's lot. In 2006, the County prepared the necessary paperwork to replat the 3 lots (Byerly, Mullens, and the County), but the only way to move forward was if Mrs. Byerly put the title of her property into her name, as her husband passed away. Mrs. Byerly was contacted at the time and indicated she had an attorney and would investigate. At that point, the property needed to be surveyed and the lot lines redrawn to correct the problem. The Prosecutor's Office advised the Board in June of 2012 that without Byerly's cooperation, there is no solution in this matter.

The Board asked Administrator Crombie to work with the Internal Services Director to obtain additional information such as the size of the parcel, the fair market value on the property, and whether there's a County purpose for the property. Commissioner Christian-Bennett is interested in whether Mrs. Byerly was able to get the house put into her name.

The Board agreed it doesn't need a meeting on November 30th and the Clerk will send notice to the newspaper.
