#### **HUMAN RESOURCES**

#### Discussion:

1. Vacation Leave Payout Policy

There are 2 other counties that currently have this policy in place and Director Kovick received an Attorney General's opinion, which indicates the Board may adopt a policy whereby an employee would be eligible to pay out a portion of their vacation leave for cash payment. Commissioner Christian-Bennett noted it's a dollar-for-dollar payout and Director Kovick confirmed.

In order to be eligible for the payout, an employee would need to have a minimum of 120 hours of vacation leave and would be eligible to convert 40 or 80 hours total. A minimum of 40 hours will need to be maintained by each employee who participates. The policy to employees would be presented in June 2020, as the sick leave payout is conducted towards the end of the year. The Board does have the option to restrict, extend or cease the policy as it sees fit.

The Board agreed to move forward with the request and Director Kovick will include the new policy, along with several other revisions to the Commissioners' Personnel Policy all at once before the end of the year.
