# **COUNTY ENGINEER'S OFFICE**

Present: Chief Deputy County Engineer Larry Jenkins

Mr. Jenkins distributed information regarding the Silica Sand Road Resolution on today's agenda and noted the apparent low bidder (Matt Winders Excavating LLC) chose to put \$0.00 under item #26 (professional liability) and the other bidder questioned the validity of the bid.

We checked their references, we worked it out with ODOT, and we conferred with the Prosecutor's Office, and upon the Prosecutor's recommendation, we still have the ability and are recommending awarding the bid to Matt Winders Excavating.

Since we are a locally administered agency, we can make those rules as long as we determine it's not going to cause a bid to be materially imbalanced. The \$0.00 amount was on the professional liability insurance, not anything that calculates or exponentially increases the bid and it does not cause a material imbalance.

We wanted to present the information to you and recommend an award to the apparent low bidder on the advice of the Prosecutor.

Mr. Jenkins also mentioned the Prosecutor has determined it does not waive the requirement of having insurance and they have insurance, this is the cost of the premium bond, that's all.

Administrator Crombie asked if we are specifically bonded for this project or if will he be listing the County as additionally insured and Mr. Jenkins noted he will follow every rule that's listed in the County Engineer's bid book and there will be nothing different because of the \$0.00.

Commissioner Tinlin asked how long has this project been in fruition and Mr. Jenkins noted 3-4 years and we are finally going to get it done.

#### Discussion:

1. Randolph Road Flooding:

Commissioner Badalamenti asked about flooding on Randolph Road.

Mr. Jenkins explained the property owner, Mr. Saal, was nice enough to allow us to come and take an assessment on his property, so we went out and met with the property owner and his attorney. We were trying to figure out how much effort it was going to be, so the Commissioners gave us the approach that we would have the County Engineer go out and remove debris and we were estimating what that cost would be, but we didn't know what it would be because we were acting in the dark.

We looked at the area and essentially there is no debris that we can remove, the culverts themselves are non-functional and that's what we encountered when we got out to the site. So

this finding is a complete change of scope as it's not just a debris removal, it's an obstruction in front of two operational pipes, and as a result, there isn't any debris for us to remove. The pipes are not functional at all.

Commissioner Badalamenti mentioned previously we discussed flooding, liability road damage and the water possibly reaching the bridge and the thought process was if it continues to happen, the road is going to be damaged and that is our liability, so what are we doing to prevent that from happening? Mr. Jenkins noted the direction from the last meeting was under the Prosecutor's direction, we can go out there and remove debris. If it's a debris obstruction, that's what we were there to do. There is no debris. The two pipes are completely nonfunctional and beyond their useful life. That's a whole other issue, we were talking about debris removal and we were grateful that the property owner allowed us to get out there, but there is no debris to remove and we have non-functional pipes. Commissioner Badalamenti asked if the non-functional pipes are the property owner's responsibility and Mr. Jenkins said they are Mr. Saal's responsibility because they are on private property. We assessed that there is nothing for the County Engineer's office to remove.

Water Resources Director Dan Blakely attended to discuss the resolution to purchase 7 vehicles for the Water Resources Department.

We need 7 vehicles for this year and the year before we did not take possession of any vehicles, before that we took possession of 3, before that, we took possession of 13 vehicles and 14 vehicles the year prior. The primary reason we stopped purchasing was due to COVID and the availability of vehicles, and we now feel there are some vehicles we need to replace. Unfortunately, the class of pickup trucks has gone up dramatically in price, even over the course of the last 2 years they've increased from \$31,000 to \$68,000.

We have a camera truck we would like to trade in and the intent of that will be for the actual equipment that's on it – the camera equipment needs 2 people to operate and this equipment needs one, so we can lessen the manpower and get more efficient use out of our workforce.

Commissioner Badalamenti asked how often a camera truck needs to be replaced and Mr. Blakely responded we would like to go 12 years, but that's dependent on what's happening with the vehicle. This is a relatively new trade and the one that we're trading in is only five years old, but we're going to save more money because the operation can be performed by one person.

Commissioner Tinlin stated I would like to request when we purchase vehicles, we try to stay within the County and I think that's very important and maybe they could do a dealer-to-dealer purchase and make sure any of our local dealers meet the state bid pricing, but anytime we make a big purchase like that, we need to stay in County. Mr. Blakely responded it's a great idea and we intend to do that by having our Facilities Manager make sure we check with all the local dealerships and as long as they can meet the state price or lower, we'll definitely move forward.

# **PUBLIC COMMENT**

Present: Larry Doak

I'm glad to be here to talk a little bit about what we're talking about that obstruct (Potter's Creek, Randolph). I just want to start by reading what Amy Hutchinson sent to us from Chris Meduri. She says hello again, I just spoke with the Prosecutor's Office and this is what they said:

Mr. Doak's email states that the County Engineer's Office is unable to do the project. Also, after County personnel went out on site in March, it was reported back that the situation is more involved than anticipated and it was suggested that an engineering and wildlife study be performed to determine the course of action in this floodplain area. At this time, the landowner has not provided consent for any improvements to be done on private property. Even if specifications were to be drafted, it is questionable whether a suitable contractor would be willing to go onto private property without the approval of the property owner. Even if a contractor could be retained who was going to do so, the Board should not send a private contractor onto private property in this situation and the Sheriff should not have to become involved in a situation of this nature.

This is outrageous to me, but that's all I want to say right now and I'll let my wife finish.

#### PUBLIC COMMENT

Present: Cathy Doak

Hello, I'm Cathy Doak from Randolph. So, you did place this order from the Ohio Revised Code asking for the removal of the obstruction to be ordered. It took nearly two months for Chris Meduri to send that order out, so we have been delayed two months already to get to this point.

Chris Meduri seems to be implying several things to me by that response: number one is that because the problem is bigger than it sounds like, he doesn't want the County to do anything

about it, number two, he claims that the property owner has not consented to improvements and I don't know why he would ever improve his property, the Ohio Revised Code indicated to remove obstructions from the property, not improve Mr. Saal's property and that should never be the responsibility of the County to improve his property. Then, he seems to be implying that bullying by the private property owner could somehow prevent us from fixing this problem.

Larry Jenkins stated there was nothing to remove, I would disagree with that, there is something to remove – the culverts need to be removed, they are the obstruction now according to them. I just want to remind you that the stormwater resolution says that the water force must be free-flowing and that it's a promise to the whole community that you will act on the stormwater rules and have the private property owner be responsible for keeping his water force clear. Then, the Ohio Revised Code gives you the power to do that and the issue is really simple that the promise has been made, the order has been executed, and obstruction has been identified and that's the culverts.

We are here asking that you will continue with efforts to remove the obstruction. The cost really shouldn't be an issue because the private property can be back-charged for that. I guess I would ask you, I know that all three Commissioners are not here today and you probably can't do anything and Commissioner Badalamenti stated it only takes 2 and we've had a discussion this morning about the letters that have been sent, I have questions about the situation, as well. I think Mr. Jenkins just said that it's not the culvert, it's the pipes on private property that are blocked. I find it very frustrating and both Mike and I had questions after receiving the letters and we are still trying to figure out what to do and there's that legal word that everybody keeps throwing at us about what we can do and what we can't do. I get frustrated.

Ms. Doak stated the Ohio Revised Code spells it out very clearly – it is an obstruction and you have the power to remove it and the cost should be passed on.

Commissioner Badalamenti stated we haven't talked about the cost because they've identified other things that could be causing issues, too and Ms. Doak responded the obstruction is still the obstruction and it has been identified and Commissioner Badalamenti replied we are still discussing that with our legal counsel as to what we can do and what we can't do. Ms. Doak asked if there was something in the works and Commissioner Badalamenti replied, we just received the letters and we're still talking.

# **PUBLIC COMMENT**

Present: Brian Ames

I didn't plan to do public comment, but I have something relevant to what they just said. A few years ago, the culvert at the end of my driveway completely collapsed and water was backing out onto the road and I made arrangements with the County Engineer, I paid for 2 culvert pipes and they installed them and took the old ones out. Sounds to me like what we're talking about here. That's an example of how this similar situation was corrected. That might be something to check into.

Commissioner Badalamenti stated Ms. Barb Tittle has a request for the Board to create a proclamation to recognize May as Motorcycle Awareness Month in Ohio and we will get that prepared.

# PROSECUTOR'S OFFICE

# Discussion:

1. Randolph Road Flooding (Potter's Creek)

Attorney Meduri stated back in March, several County agents went out to inspect the area and the landowner (Mr. Saal) did allow us to go onto his property to look at the situation. The bottom line with this is, that it's unfortunate, I mean, we've all tried to help her, and we'd like to help neighboring property owners, but the statute they cite is not a criminal statute, it's discretionary, what we call civil remedial statute. This Board is not mandated to proceed under that statute. There's no statutory requirement, the Board may, but the problem you have here is the landowner is not at this point, open and giving us consent and I'm not comfortable sending anyone out there without consent or a court order. For us to get a court order, we would actually have to line up an expert who would have to say what needs to be done to solve the problem in the whole floodplain area.

Commissioner Badalamenti stated the whole floodplain area, not just the street that's getting flooded because Chief Deputy County Engineer Larry Jenkins stated there's no blockage, the culverts are at the end of their useful life. Attorney Meduri stated, the accessway was put in back in the 1930s, so there's no entranceway to the culverts — essentially there's an opening before and an opening after. I've been told Mr. Saal did some work within the ditch to remove sediment, so how much better he made it, I don't know. The bottom line is that this is not a good situation. Even if the County Engineer isn't able to do the project due to the scope, we would be forced with having to try to find a private contractor, whether or not we could find a private contractor to go onto private property without consent, that in and of itself is risky, we would have to get the Sheriff out there and it's just not a good scene.

Commissioner Badalamenti noted I hear two issues; you've got one downstream that has to do the wildlife study and that's to the right of where we're getting flooded and then you have the first area that seemed like it might have been blocked that is clear now and then we find out to the left of that is where the culvert pipes are located and blocked. I thought when we spoke the first time about this, we were worried about damage to the road, and if the flooding continues the road is going to be damaged. There's a bridge close by and the water is coming right to the bottom of the bridge. These are two separate issues. What's the major problem and what's the immediate fix? Does the immediate fix include going on a person's property or do the culverts run along the side of the road? Attorney Meduri responded that the culverts we're talking about are way back on Mr. Saal's private property and merely serve the private access way to the back of his property. So who put those in, who knows, it was decades ago, but the bottom line is the culverts on private property are at their end of life.

Attorney Meduri stated we do have the right of ways that we can operate in and I would have to defer to the Engineer's Office, but I would hope that if the road is being impacted, there's some type of fix where we could stay within our right of way to solve that problem.

Attorney Meduri went on to say concerning the road, and I'll be frank with you, last fall Director Roberts and myself were pretty much on the same page before the road issue was mentioned that this is something the County should stay out of. I understand the Doak's position and we'd like to help them, I know people don't like to hear this, but they have a private remedy whereby they could bring a private nuisance action, I'm not saying they should or shouldn't, but they could retain a lawyer and bring a private trespass issue against the property owner. Again, that's between them. They could also petition this Board of Commissioners for a petition ditch, but the problem with that is you would have to do a study and then assess the benefiting property owners. So, there's no easy solution, there are solutions, but for this Board to act under that statute where we don't have consent or court order and getting a court order would take time, we would have to line up the expert, we'd have to sue for an injunction, we'd have to win the case, then the court would issue an injunction from there. Then, the landowner would have his due process in court, because remember, everybody has land rights, both the Doaks and Mr. Saal and before we go on anybody's private property, we have to make sure this Board is doing it under the color of law.

Commissioner Badalamenti stated I was thinking that the culvert ran alongside of the road and you're saying it is in the back and way off the road and that's what they believe to be causing the flooding? Attorney Meduri stated I'm not saying it is or it isn't, Mr. Saal's position is there are at least four or five beaver dams upstream that are impacting it, hence the thought of an engineering and wildlife study to see what the solution is, but that is expensive.

Commissioner Badalamenti stated if the County Engineer says the integrity of the road has been compromised because of what we believe is water-related, would we then try to find out where the water's coming from and would we have the right to fix it, and Attorney Meduri stated it would be best to let the Engineer's Office speak to their roads, but if the County road is being hurt, steps would be taken to fix that — whether that's within the right of way or something else. Commissioner Badalamenti asked if that's what we talked about the first time — if County roads are being damaged, we would have the right to go in and fix it and Attorney Meduri stated you can always do it within your right of way, but even when you need to go off your right of way without consent, a lot of times we do appropriation actions eminent domain where, you know, we give a landowner their due process, and that takes time.

The Board thanked Attorney Meduri for the explanation.
