# 1. Shalersville Well No. 3

In response to the discrepancy on the quote, Deputy Director Weber contacted Ohio Drilling, who stated the quote was correct at \$111,078. The material costs have increased because the material on-site was recycled material (original quote of \$98,388) and during the time the Water Resources Department went out for proposals, the recycled material ended up going to another municipality. The March 14, 2019 quote is for new material that hasn't been ordered and the cost is \$111,078.

Attorney Meduri provided a March 20, 2019 e-mail, which indicated the Board could proceed with an emergency for this project under Ohio Revised Code Section 307.86(A). The Board agreed to consider the resolution later in the day after it adopts the Consent Agenda.

The Board asked if Ohio Drilling indicated the County would receive recycled material initially and Deputy Director Weber will check with Director Roberts.

  Two social workers were sent out of state to pick up a youth in foster care and the workers went through an EZ Pass toll booth on the Pennsylvania Turnpike on January 11, 2019 by mistake instead of paying the toll. The County received two bills, one for the toll \$28.30 and one for the violation \$98.10. Director Jeffries was able to contact the Violations Department to get the administrative fees reduced to \$58.10; Total \$86.40.
