II. APPROVAL OF MINUTES:

I. Sewage Treatment System Variance Application – Ferguson Road, Streetsboro City

Will Duck, Sanitarian-in-Training, discussed the variance for Ferguson Road asking for 6" instead of 8" perch water table. The State of Ohio had approved the 6" limit but Portage County defaulted to 8".

VII. DISCUSSION REPORTS

A. Administration and Personnel: Mrs. Filing updated the Board on the two open job postings.

The Registered Sanitarian position has received 52 applicants. We have interviewed 18 and hired 2.

The Epidemiologist posting has received 93 applicants. Mr. Diorio, Mrs. Ferraro, and Mrs. Lehman held 6 interviews. They are recommending one hire.

- B. Fiscal and Accounting: Mrs. Stall presented the July Cash Basis Report. There were no questions.
- C. Nursing: Mrs. Ferraro reviewed the 2017 Annual and July Communicable Disease Reports. They are starting to get busy with back to school shots and getting ready for flu. The nasal spray is coming back.

West Nile Virus questions were presented. 50% of Portage County townships are positive for WNV.

Nursing students combined efforts and developed a brochure for Gun Safety that was included in the Board packet. Gun locks were also given at the County Fair.

- D. Environmental Division: Mrs. Smith expressed how busy the Division is and everyone is working hard. She reviewed the status of the 2018 Board Orders. There will be at least ten WPCLF contracts to fix fifteen STS. Food inspections are going very well this year compared to last year for Fair vendors.
- E. Health Education and Promotion: Mrs. Lehman encouraged everyone to come and see them at the Fair.
- F. Health Commissioner Mr. Diorio believes the site visitors for Accreditation have been selected. Our flu and pneumonia vaccines should arrive shortly. We have been working with the hospital and NEOMED Pharmacy students for additional clinics. This might include drive-thru clinics using steps or stations.
