Accidents & Incidents Happen

Accidents and incidents may happen on your property. Any fecal/blood/vomitus incident or accident resulting in serious injury, death or assistance from medical personnel shall be recorded as required by the Ohio Administrative Code (OAC) as detailed below. All records shall be maintained for two years.

Personal Injury

- ◆ OAC 3701-31-04(a)(x)
- ◆ The OAC requires the operator of a public swimming pool to prohibit patrons with an obvious infectious wound from using the pool.
- ◆ **Weekly Pool and Operation and Incident Report Form available at:**

- ◆ **Record:** The operator is required to record all injuries.
- ◆ **Report:** Name, age, address, phone number, and sex of injured person. Along with the name of the facility and address where accident occurred.
- ◆ **Describe the incident:** Date, time, was the facility open at the time of incident, lifeguards present, witnesses, water depth in feet and inches, setting and the location.
- ◆ **Describe the injury:** Type of injury and area injured.
- ◆ **Actions taken:** Whether EMS was called and/or injured person was transported to a medical facility. Was the injured person immobilized, oxygen supplied, and rescue breathing/resuscitation required? Did staff offer or provide first aid? Did injured person return to water activity?

Fecal/Blood/Vomitus Accidents

- ◆ OAC 3701-31-04(a)(xi)
- ◆ The OAC requires that operators of public swimming pools are to prohibit patrons that are observed passing feces or urine.
- ◆ **Weekly Pool and Operation and Incident Report Form available at:**

- ◆ **Record:** The operator is required to record all accidents.
- ◆ **Close:** In the event of a formed stool or diarrheal fecal accident pool shall be closed and no bathers shall enter the water until the disinfection process is completed.
- ◆ **Remove:** All fecal matter and dispose in a sanitary manner. Vacuuming stool is **not** recommended.
- ◆ **Disinfect:** Guidance to disinfect (depending on incident) is located at http://www.co.portage.oh.us/PCHD/PDF/Pool%20Spills_Fecal%20Incident%20Response%20Recommendations%20for%20Pool%20Staff.pdf
- ◆ **Report:** Date, time, description of event, corrective measures, and contact information on a separate page for ALL patrons involved.

2017 Updates

◆ Certified Pool Operator Certification (CPO)

PCHD will be hosting a certified pool operator course in early 2018. Keep an eye out for a future mailing!

◆ Things to Keep in Mind:

- Maintain test results and service records for automatic chemical controllers and SVR's for two years.
- Lifeguards, if provided or required, shall have a current and valid certification of lifeguard training and current and valid certification in infant, child and adult CPR. Certifications shall be maintained by the operator for review at all times.

- If you do not have a lifeguard on duty your sign shall read, "Warning, No Lifeguard."

◆ Top 3 Violations Found in 2016:

1. Meeting minimum testing requirements
2. Turnover rate is under required parameters
3. Inadequate disinfection levels

◆ We Heard You - 2016 Survey Results

Based on the 2016 pool survey results, there was a need for an increased focus on perimeter gates and barriers. Perimeter barriers are to be in good repair at all times, to prevent unauthorized entry. Remember, perimeter barriers shall be with gates or doors that are self-closing and lockable. For more information see ODH Pool regulations: OAC 3701-31-04 (B)(6)(s).
