Airport Manager

Robert Hartigan, the future airport manager for the County Commissioners, was in attendance, and he provided the following report:

- 1. The reils were reported as not functioning. Two notams have been issued stating this "out-of-service status; however, the reils are working, but the official inspection after installation was not initiated which could be the reason for the current status on record. Mr. Hartigan will discuss this issue with the FAA.
- 2. The County Commissioners will vote on October 12, 2023, to accept the agreed judgement entry and order for the dissolution of the Portage County Regional Airport Authority.
- 3. Mr. Hartigan shared information on a SMART 100% grant program through ODOT. The purpose of the grant is to conduct demonstration projects focused on advanced technologies to improve transportation efficiency and safety. The program includes 2 phases: planning and implementation. The commissioners have applied for this grant for a potential drone project to enable emergency medical and emergency logistics.
- 4. Mr. Hartigan has been seeking quotes for the ice/snow control for the airport grounds for 2024.
