Proposals will be received for the following items of work:

**STREETSBORO STATE ROUTE 14 WATER MAIN REPLACEMENT**

The Contractor shall provide all labor, material and equipment necessary to construct 6,307 lineal feet of 16-inch pvc water mains by means of open cut trench excavation or horizontal directional drill installation. Line gate valves, bends, fittings, and hydrant assemblies are included in the project. The project travels along State Route 14 through Streetsboro, Portage County, Ohio.

Estimated Costs of Construction:

Streetsboro State Route 14 Water Main Replacement: \$810,000.00

The Contractor shall familiarize himself with all of Section 20, including 'Information and Instructions to Bidders' and 'Special Construction Requirements' prior to bidding.

10.01 ADVERTISEMENT FOR BIDS

The Bid Guarantee is conditioned to provide that if the Bid is accepted and awarded, the Bidder will enter into a contract with the County and will file a Performance Bond as required.

The Bidder to whom the Contract is awarded will be required to furnish a Performance Bond in the sum of 100 percent of the Contract price for the faithful performance of the Contract. If the Bidder selects "Bid Guarantee" Option A, the Bidder may use this Bond as the Performance Bond.

Each Proposal must contain the full name of the party or parties submitting the documentation and all persons interested therein. Each Bidder must submit evidence of its experiences on projects of similar size and complexity. The bidder shall purchase the plans and a contract book to become a qualified participant before final bid submittal. All questions shall be directed to the Portage County Water Resources Department at 330-297-3670. The Owner intends and requires that the project be completed no later than one hundred and eighty (180) calendar days after the "Notice to Proceed" is issued and complete restoration within thirty (30) days thereafter.

Each Proposal must be sealed and marked “**Streetsboro State Route 14 Water Main Replacement, Project No. SH-W (19-160)**”.

Domestic Steel use requirements as specified in section 153.011 of the revised code apply to this project. Copies of section 153.011 of the revised code can be obtained from any of the offices of the Ohio Department of Administrative Services.
