● FOR THE SECOND TIME THIS YEAR; THE COMMITTEE VOTED TO RAISE THE FED FUNDS TARGET RANGE TO 1.75%-2.00%

● “LABOR MARKET HAS CONTINUED TO STRENGTHEN AND ECONOMIC ACTIVITY HAS BEEN RISING AT A SOLID RATE”

● INFLATION HAS MOVED CLOSER TO 2 PERCENT WHILE LONGER-TERM INFLATION EXPECTATIONS ARE LITTLE CHANGED

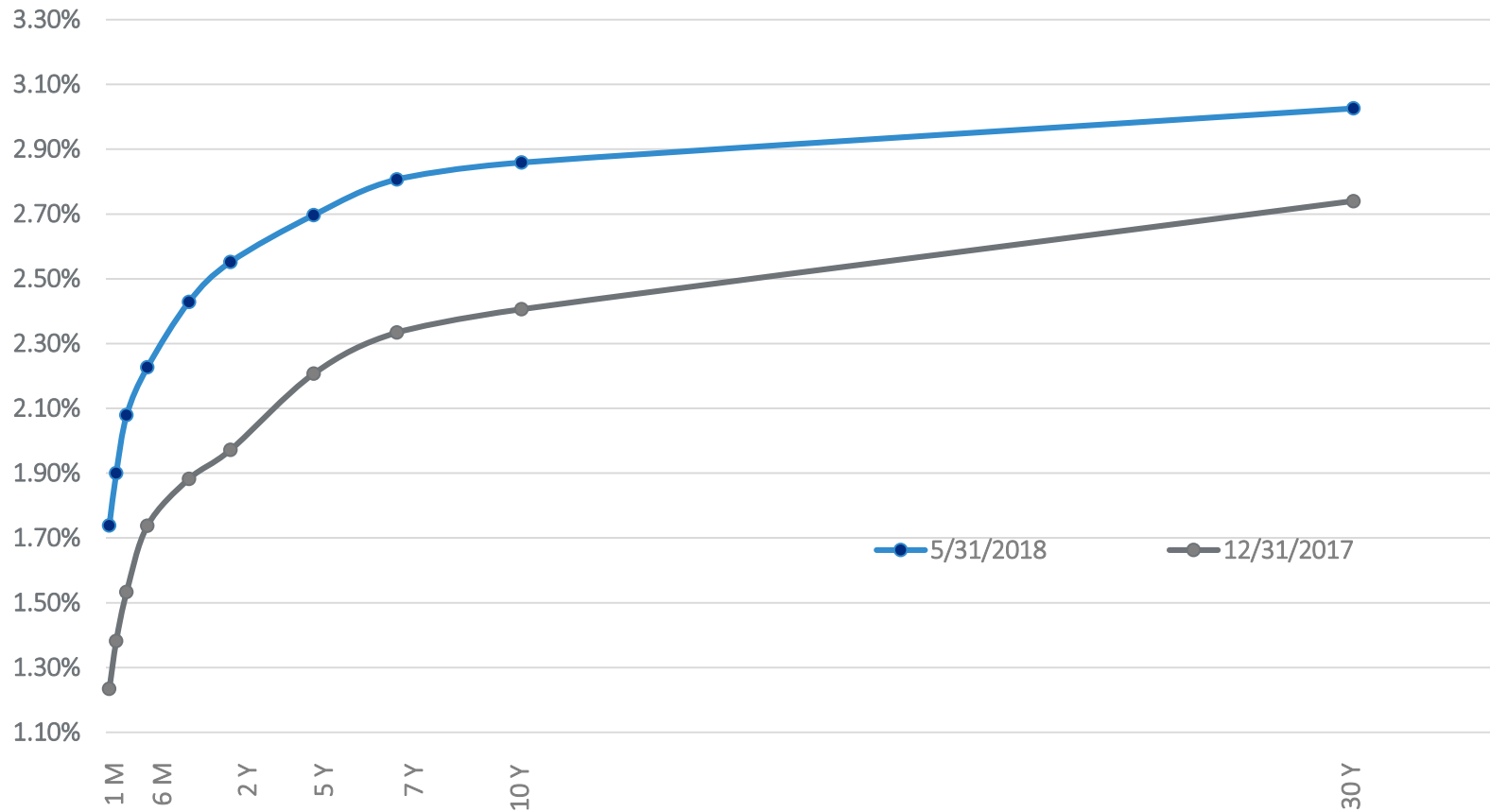
● “RISKS TO THE ECONOMIC OUTLOOK APPEAR ROUGHLY BALANCED”

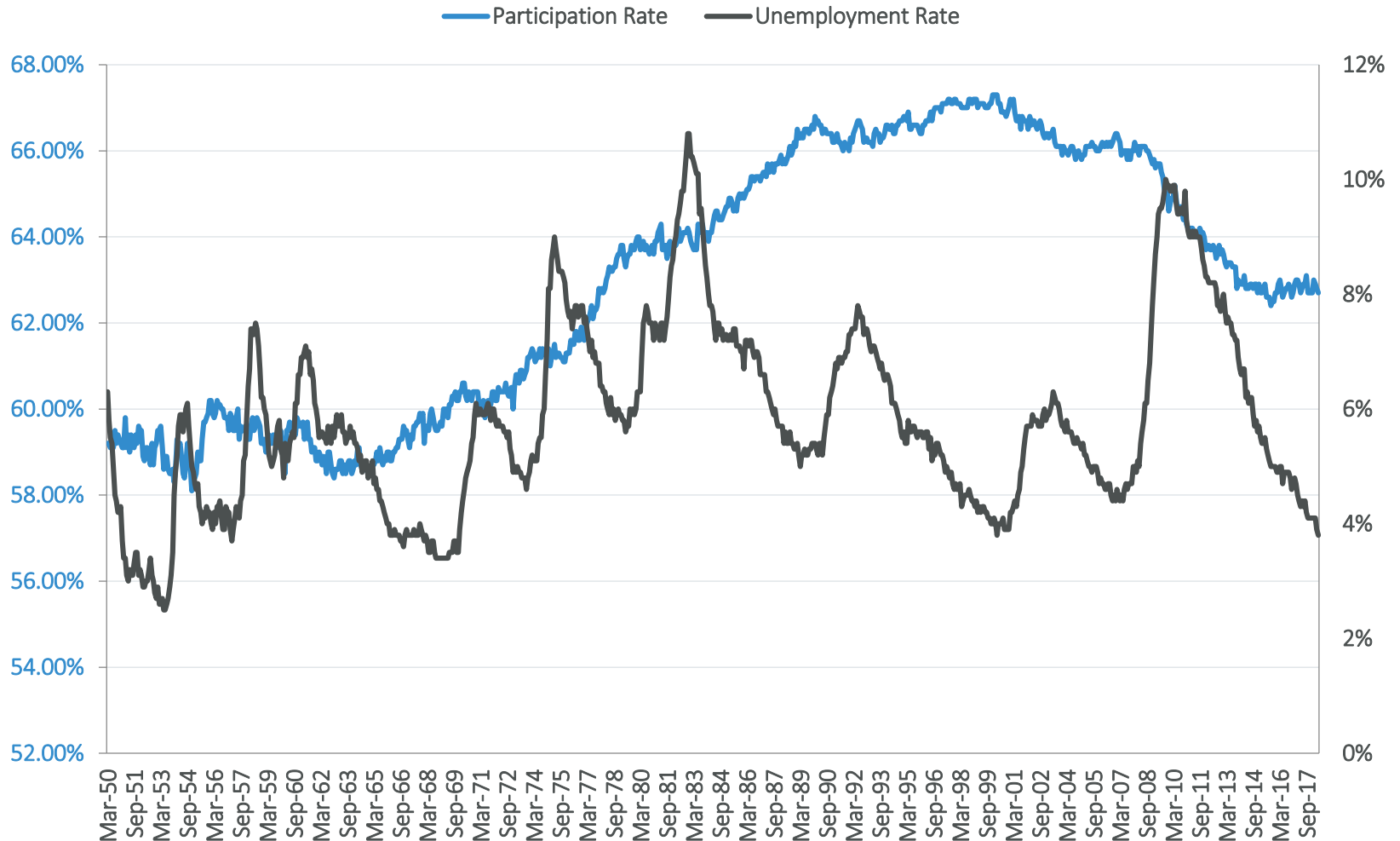
YIELD CURVE COMPARISON

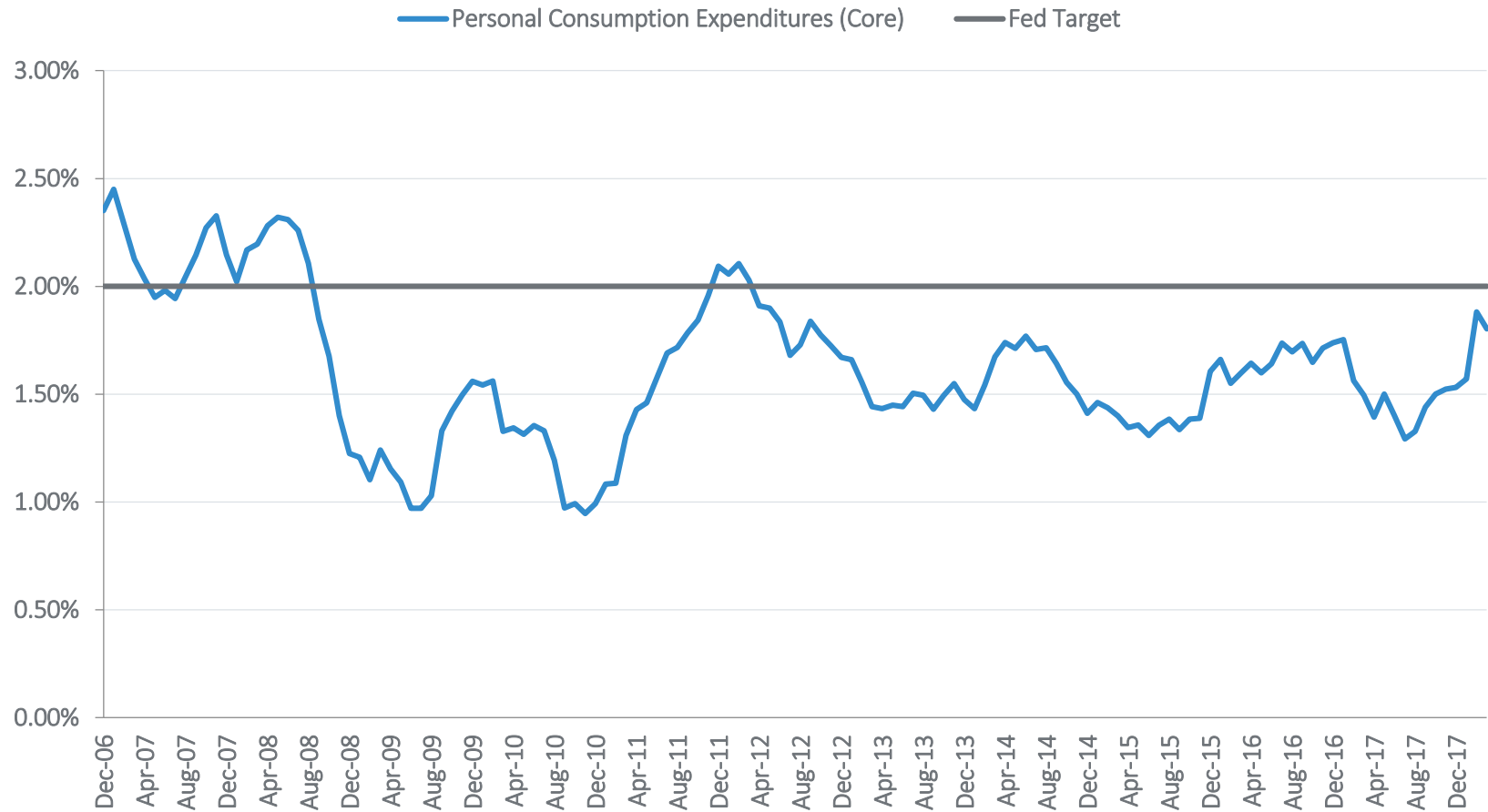
Unemployment rate vs participation rate

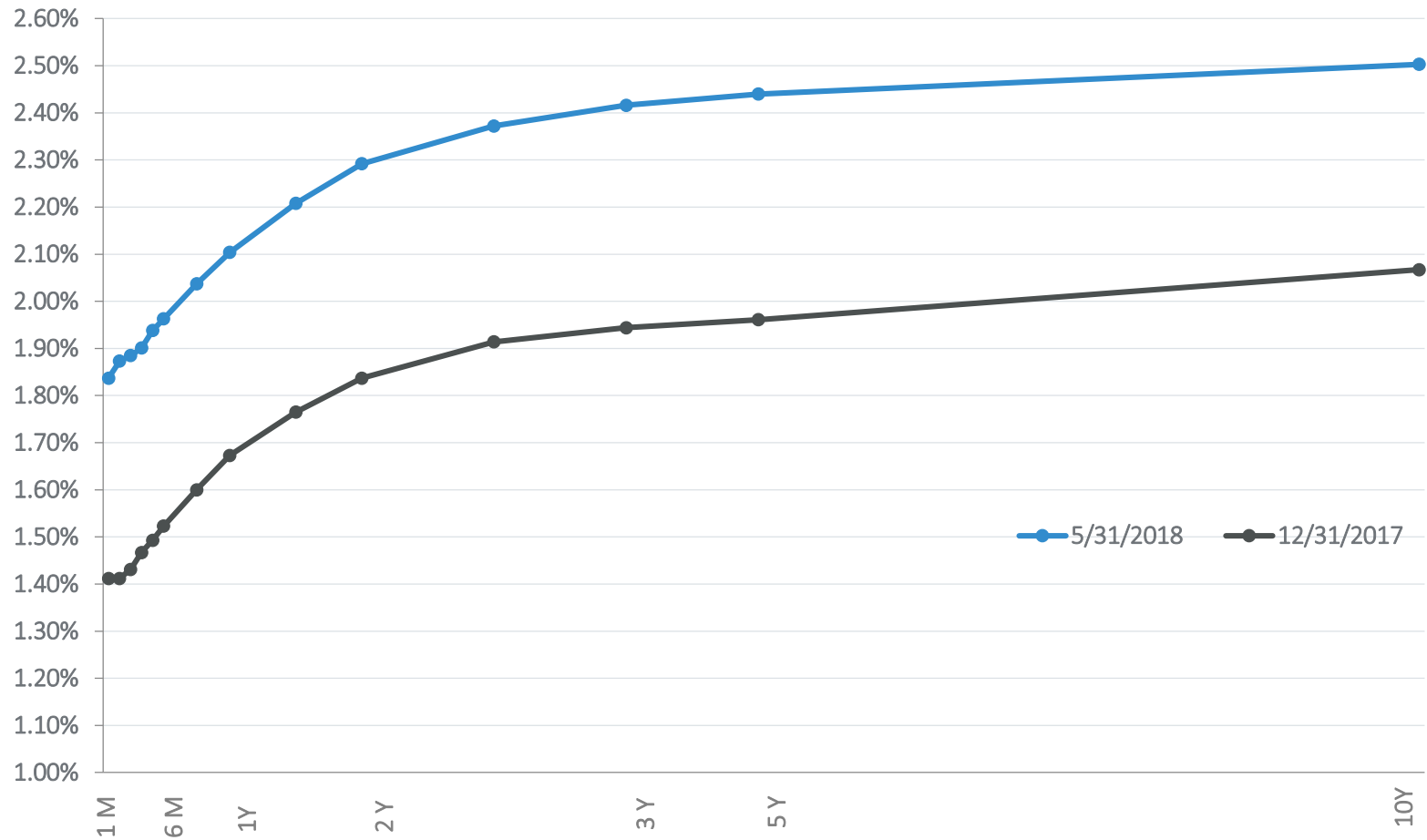
U.S. 5-Year Breakeven Index

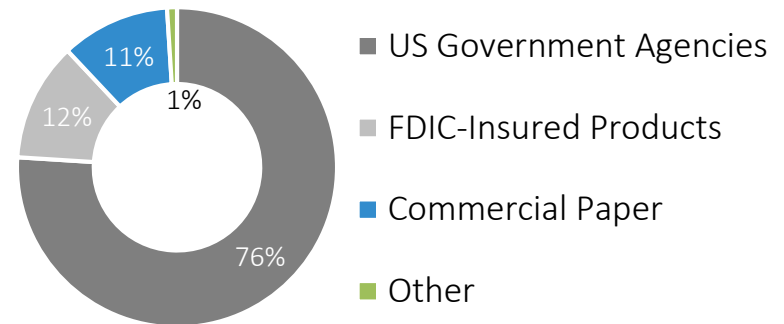

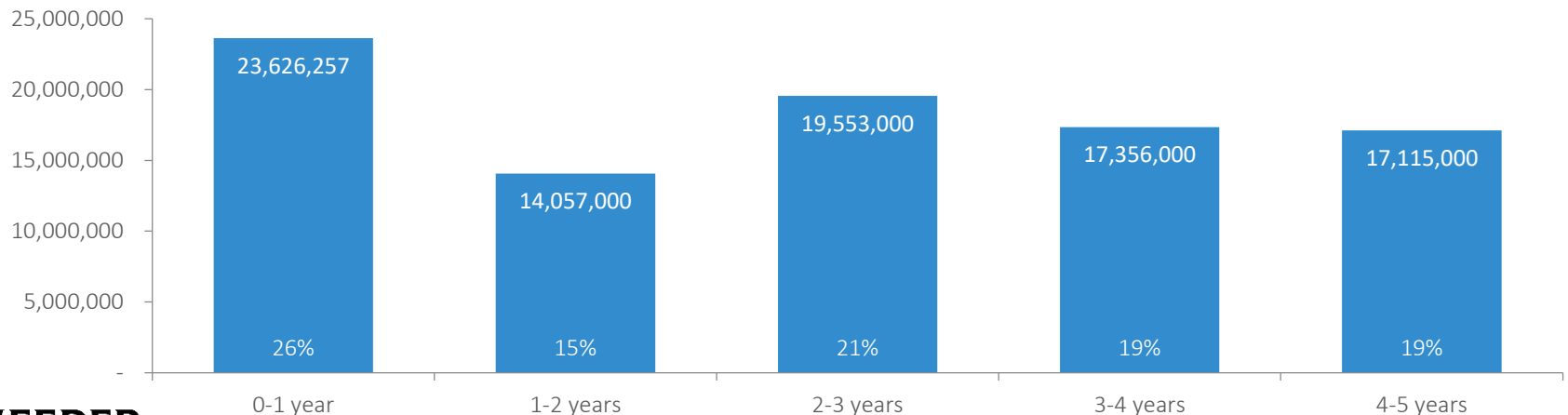
