AN EXPLANATION OF PORTAGE COUNTY PROPERTY TAX RATES

***Voted Tax Rate:** the total rate approved by the voters in your taxing district, for support of your school district, library, municipality, vocational school, or county wide services. This rate also includes 10 mills of unvoted taxes guaranteed by the Ohio constitution.

***Effective Tax Rate:** your tax rates after the tax reduction factor is applied. Ohio legislation known as House Bill 920 protects you from unvoted increases in taxes. Passed in 1972, HB920 reduces your rate as property values in your district increase during triennial reappraisals and updates.

***Special Assessments** - charges by your city or county to cover the cost of improvements or services.

***Homestead Exemption** - a reduction in property taxes available to senior citizens and disabled homeowners with limited incomes.

IMPORTANT INFORMATION

***Closing Date** - the closing date for first half 2015 Real Estate tax collection is February 17, 2016.

***Delinquent Taxes** - The State of Ohio imposes a 10% penalty on the total amount of Real Estate tax due each half, interest charges will be added if taxes are still delinquent when the next collection period opens. Delinquent taxes may be subject to a tax lien sale.

***Payment Plans** - Payment plans for delinquent taxes are available. Please call 330-297-2243 for more information.

***Foreclosure** - Real Estate taxes that are delinquent can be subject to foreclosure sale.
